CULTURES WILL BE REQUIRED FOR ALL MARES RETURNING FOR A THIRD HEAT, AND FOR ALL SUBSEQUENT COVERS.

CHECK ONE:

- 1. **DOMESTIC MAIDEN MARES** (mares not previously bred)
No CEM testing required.
ALL maiden mares must be jumped **before** first trip to breeding shed.
- 2. **DOMESTIC FOALING MARES NEVER CLASSIFIED AS MEDIUM OR HIGH RISK**
No CEM testing required.
- 3. **DOMESTIC BARREN MARES NEVER CLASSIFIED AS MEDIUM OR HIGH RISK**
ALL barren mares must be accompanied by a negative aerobic uterine culture on first trip to breeding shed. **NO EXCEPTIONS.**
- 4. **MARES IMPORTED AS MAIDENS**
No CEM testing required for mares imported as maidens which have been qualified for cover in Kentucky.
Note: first three mares bred following a mare imported as a maiden must have a CF test drawn 15 - 40 days post breeding. All fillies and mares of foreign origin which have been imported as maidens in previous years (or which have been in a foreign country--Canada excluded) which have **not** been qualified for cover in Kentucky during the previous breeding seasons must have two (2) sets of cultures from the clitoral fossa, clitoral sinus(es), and cervix before being qualified for cover. One set of such cultures must be obtained in early estrus, the second set may be obtained at the discretion of the attending veterinarian during a period of 7 to 14 days either before or after the cultures taken in estrus. Also, one negative CF blood test is required prior to breeding.

- 5. **FOALING OR BARREN MARES IMPORTED FROM COUNTRY PREVIOUSLY UNDER CEM QUARANTINE**
Contact the State Veterinarian's Office (502-564-3956) for required procedures. A copy of the quarantine release must accompany mare on first trip to breeding shed. Also must have negative CF blood test.

- 6. **ALL IMPORTED MARES (EXCLUDING CANADA) NOT PREVIOUSLY BRED IN THE U.S.**
Must have three 3 sets of negative CEM cultures prior to being bred in 2012.
